



Parent and Player Skills and Training Financial Agreement to Club Gold West Volleyball Club

I _____(Parent Name),

do agree to commit financially to Club Gold West Volleyball Club 2020-2021 Season.

Player and Parent understand and agree to pay \$200 deposit to Club Gold West Volleyball Club upon acceptance of their team placement after tryouts to hold their roster spot for the 2021 club season, of which \$200 will be applied to their total team fees for the season. Player and Parent also understand that the \$200 deposit is non-refundable should the player or parent change their mind and opt not to participate in the program. Player and Parent agree to pay their installments based on the fee schedule outlined in the handbook until their balance is \$0.00 so that the player can participate in the 2021 season.

Player and Parent understand and agree to pay the total amount per player for team dues according to the team the player is assigned to.

Parent and Player agree to pay the total fees due on time as laid out in the payment agreement. Player and Parent understand that all payments must be received by Club Gold West Volleyball Club by and no later than the 5th of each month to be considered on time. Player and Parent understand there is a \$10.00 late fee for any and all monies collected after the agreed upon date.

Parent and Player understand that there are no refunds of any monies paid once a player accepts a spot on a team for any reason up to and inclusive of injury, mental health, family relocation, dismissal from program due to violation of Club Gold West Volleyball Club Policies, OVR policies, and JVA Policies. The exception to this rule for the 2021 season due to the COVID-19 pandemic is as follows: Club Gold West will reimburse players \$40 for any competition cancelled due to the pandemic, if another competition is not able to be scheduled in its place. These are the only fees that the club will refund.

Parent and Player understand the monies paid to Club Gold West Volleyball Club do not guarantee any particular amount of playing time, positions within a team lineup, leadership roles, or duties.

Player and Parent understand that monies being paid to participate in the 2021 season constitutes a commitment to No Limits Volleyball Club as a whole and not one particular team. In rare events, some players may be moved to other teams for competition purposes. The Parent and Player agree that they are responsible for their signed and agreed upon team fees regardless of the team they compete on for any given event. Club Gold West Volleyball Club will not seek further compensation if a player moves rosters at their discretion, however if the Parent or Player requests a team change that is in excess of their current fee agreement, they are responsible for the additional fees.

Parent and Player understands that all team fees are to be paid using paypal, cash, or check (which can be made out to Club Gold West VBC). Furthermore, Parent and Player agrees that Club Gold West Volleyball Club is providing a service, rather than a product, and therefore waives the right to dispute any payment for services made via cash, check, credit, or debit card to Club Gold West Volleyball Club.

Parent and Player understand that the following items are INCLUDED of their Club Gold West Volleyball Club Fees:

- Tournament Fees
- Coaching Fees
- Facility Fees
- Equipment Fees
- Administrative Fees

Parents and Players understand that the following are NOT INCLUDED in their Club Gold West Volleyball Club Dues and are additional costs:

- Cost of Travel for players/parents to and from Practices and Tournaments (Regional or National)
- USAV Player Membership Fees

Parent and Player further agree to the following:

- OVR Medical Waiver and Release of Liability
- All Club Events including but not limited to the Player/Parent Meeting, all practices and tournaments, and all team meetings
- Club Gold West Volleyball Club Player/Parent Guidelines & Policies

Player and Parent understand that by signing this contract, _____(player name) is required to participate with the team listed above for the 2021 Club Season beginning immediately upon signing. Player and Parent understand and agree that by signing this contract they cannot play or participate with any other club team or program from the date of this contract being signed through the conclusion of the season.
